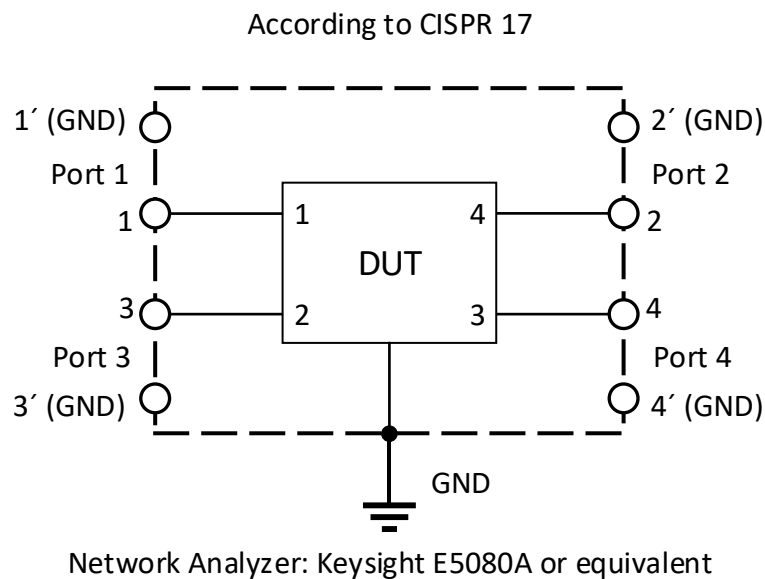

Soldering:



Packaging:


